ONEOK Field Services Company, L.L.C. (OFS) is a subsidiary of ONEOK Partners, L.P. OFS owns and operates natural gas gathering and processing systems in the Anadarko Basin of Oklahoma and the Hugoton and Central Uplift Basins of Kansas with more than 10,000 miles of gathering pipelines and approximately 0.6 billion cubic feet per day capacity at nine processing plants.

Maintaining Safe Operations

Operating pipelines in a safe and compliant manner remains a significant priority. Our pipeline control center operates 24 hours a day, seven days a week. Control Center Technicians use satellite and computer technology to monitor pressure and flow along the pipeline systems. We also perform driving and walking patrols on a routine basis to mitigate corrosion, minimize the potential for third party damage and address other outside forces, such as erosion and flooding. Operations and maintenance personnel are located at many points along the pipeline systems.
